# How to Host a Site Visit with Your Local Representative

Following the last election, which saw Republicans regain the White House while maintaining control of most state legislatures, governorships, the U.S. House of Representatives, and the Senate, major health care policy reforms are again likely. In this environment, it's more important than ever for practices to continue to engage state and federal elected leaders on issues impacting community-based care.

#### **Importance of Site Visits**

One of the most effective ways of doing this, is by hosting site visits. Such visits are commonly used to immerse legislative officials in the day-to-day operations of a community-based practice. From the front lobby to the infusion suite, from HIT and medical records to any ancillary services available, officials are able to experience first-hand and from a clinical perspective, how integrated treatment is delivered to patients using the highest standards of care.

The need for education in today's complicated legislative and regulatory environment has never been greater. With your help, officials and their staff may review services provided for their constituents.

## **Best Practices**

Each visit should be planned for a time period ranging from 45 to 60 minutes. While this is certainly not enough time to explain all that is involved in practice operations, it does provide a snapshot that many officials have found greatly valuable in showcasing the model and delivery of care.

Upon arrival, we recommend the practice physician greet the official and facilitate a pre-planned itinerary. This usually includes a 30-minute tour focusing on the delivery of care, followed by a more formal, sit-down conversation concerning the latest health care issues of importance to your practice and your patients.

During each tour, it's beneficial to highlight pharmacy services, medical recordkeeping and HIT, financial and patient assistance resources provided by the practice, and common follow-up procedures. The key is to help the individuals on the tour better understand how a patient interacts and benefits from the entirety of services that your practice provides.

Visits should always conclude by exchanging necessary contact information and a discussion of follow-up communications from the practice to the official's staff and vice versa.
